- 1. All quotations given by us are not covered by general conditions of contract, particularly in regards to insurance, retention sums and liquidated damages.
- 2. This quotation is subject to confirmation, or withdrawal at any time, until an order is accepted by us. Unit prices are valid only when an order is placed for our total offer.
- 3. Prices are based on current cost of materials, wages and labour conditions, at the date of the quotation. If at any period after the date of quotation increases occur in these items, then the quotation price will be adjusted to allow for such increases.
 - Rise and fall adjustments will be calculated in accordance with A.B.S Index 6427.0 Table 14 Index 24 for materials and A.B.S Index 6302.0 for labour.
- 4. Payment shall be thirty days EOM to approved customers.
- 5. Goods and Services Tax is not included unless stated in our quotation.
- 6. Special packing or crating will be charged extra at cost.
- 7. All goods delivered to the purchaser shall remain the property of Aussie Switchboards until they have been paid for in full by the purchaser.
- 8. Delivery to site is included unless otherwise stated. Marine insurance is covered by Aussie Switchboards. Cover ceases on delivery once the goods have been lifted from the vehicle or conveyance and placed on the ground or loading dock immediately adjacent thereto. Off-loading or site handling is not included.
- 9. All goods manufactured by us carry our warranty as to materials, workmanship, and conformity to description or instructions. Any defects in goods manufactured by us due to faulty workmanship, occurring within twelve (12) months from date of delivery, will be made good by us. Faults in equipment not manufactured by us, but used in the construction of switchboards will be promptly inspected by us, up to a period of twelve (12) months from date of delivery, and all facts will be referred, without obligation to us, to the manufacturer and all parties concerned. We disclaim all liability for all consequential damage.
- 10. In the absence of any specified cable schedule or other agreement, terminations for external cables will be provided to suit copper cables within the range nominated by the switchgear manufacturer's technical documentation for standard product, i.e. no accessories.
- 11. Motor control centres include layout drawings only. All single line, wiring and terminal drawings to be provided by others, and all drawings suitable for manufacture must comply with AS1102.
- 12. Progress and offsite payments: Unless otherwise stated in our quotation, work completed and/or materials purchased and held in our works at the end of any one (1) month will be invoiced. Payment will be due as per our trading terms. On completion of manufacture or service, the final invoice will be raised.
- 13. Supply authority fees, stand-down allowances and site works on public holidays are not included unless stated in our quotation.
